## PET HOTEL BOARDING AGREEMENT

This Agreement is by and between 4 Paws Elegant Resorts and the pet owner whose name and whose signature appears below (hereinafter called "Owner").

Following are the terms of service for the stay of Owner's Pet at 4 Paws Elegant Resorts.

**1. DISCLOSURE:** By signing this Agreement and leaving Pet with 4 Paws Elegant Resorts, Owner certifies to the accurate disclosure of all information provided to 4 Paws Elegant Resorts either in writing or orally about the Pet and Owner specifically represents that he or she is the sole owner of the Pet. Owner agrees to disclose to 4 Paws Elegant Resorts all known medical conditions and/or behavior problems, which may affect Pet's care. Owner specifically represents to 4 Paws Elegant Resorts that Pet is healthy and meets 4 Paws Elegant Resorts's published vaccination standards. Owner represents that each time Pet is brought to 4 Paws Elegant Resorts, Owner is recertifying that Pet is in good health and has not had any communicable illness of any kind for 10 days prior to visit. Owner further agrees to inform 4 Paws Elegant Resorts of any changes in Pet's condition and/or behavior prior to subsequent visits. 4 Paws Elegant Resorts reserves the right to refuse service to any Pet for any reason, at any time, including, but not limited to: pets lacking proof of vaccinations, pets displaying signs of untreated or potentially contagious conditions and/or pets exhibiting aggressive or unacceptable behavior. For the purposes of this Agreement, the terms "Pet" or "Pets" refer to all pets under said ownership of Owner who utilize services at 4 Paws Elegant Resorts, either now or in the future. ALL PETS ARE BOARDED AT THE OWNERS RISK.

**2. PAYMENT:** Owner agrees to pay the applicable service rates in effect on the date Pet is checked into 4 Paws Elegant Resorts and to pay for any additional services requested by Owner. Payment for all accommodations and services reserved will be paid for at time of check-out.

**3. ACTS OR BEHAVIOR:** Owner agrees to be solely responsible for any and all acts or behavior of Pet while in the care of 4 Paws Elegant Resorts, including payments or costs of injury to staff or other animals or damage to facilities caused by Pet. Owner also understands that air horns, citronella spray and, in extreme cases, muzzles may be used for the protection of other pets or staff. Owner further agrees to indemnify 4 Paws Elegant Resorts or its employees or members or other agents or losses for damages of any kind suffered by 4 Paws Elegant Resorts or its agents as a result of Owner's failure to inform 4 Paws Elegant Resorts of any pre-existing condition Pet may have (such as illness or aggression problems) or which were otherwise caused by Pet.

**4. MEDICAL ATTENTION:** In the event of an injury, emergency or when 4 Paws Elegant Resorts, in its sole discretion, deems medical care is important to Pet's health (including, but not limited to: vaccinations, fleas, ticks, diarrhea, rashes, cuts, etc.), Owner authorizes 4 Paws Elegant Resorts to obtain medical attention for Pet. Owner grants to 4 Paws Elegant Resorts the full power of decision-making involving the medical treatment of Pet (including transport and care to and from any agent) and agrees to pay for all costs associated with said medical treatment. Owner hereby agrees to reimburse in full all medical costs upon departure.

**5. ASSUMPTION OF RISK:** 4 Paws Elegant Resorts agrees to exercise reasonable care of Pet during its stay and, if applicable, during transport. Owner is aware that employees of 4 Paws Elegant Resorts are not veterinarians and do not have backgrounds in animal medicine and are not expected to diagnose or detect illnesses in the pets at 4 Paws Elegant Resorts. Owner acknowledges that no amount of vaccination requirement, sanitation or personalized care can prevent pets from contracting an airborne virus or communicable disease. Owner further understands that pets are pack animals, lead with their teeth, paws, are unpredictable in nature and no amount of supervision can be 100% certain to prevent pets from being injured. Owner understands these risks of illness, disease or harm and hereby releases 4 Paws Elegant Resorts, its employees, members or other agents, from any and all losses, damages, costs and expenses arising out of or in connection with any communicable disease, airborne virus, or any other medical condition or injury contracted by Owner's Pet at 4 Paws Elegant Resorts. Furthermore, if Pet is transported to or from 4 Paws Elegant Resorts by 4 Paws Elegant Resorts staff, Owner holds 4 Paws Elegant Resorts harmless in the event of injury or accident during transportation.
